Terms & Conditions :-

1. Max.Share Limit- 20,000 /- Rs (Each member will increase share money upto max.limit , as per convenience/requirement)
2. General Loan will be normally 5 times of the total deposit amount (share money & CD)of the applicant.nj
3. **4 (four) sureties (members of the society) must be required for any loan.**
4. Any member can give his/her surety only for 02 loans at one time.
5. Minimum share money/CD 5000 rs, must be available in the account of surety.
6. Surety must not be a defaulter.
7. Loan of more than 75,000 Rs. requires additional surety of fixed assets/ FD/Gold/Govt. Employees, etc.
8. Loan will be issued through cheque to any member.
9. Issuing Loan is not compulsory. Loan Criteria must be completed along with Loan application form
10. The Managing Committee has full right to examine the loan applications as per terms & conditions of the society and further accept or reject the same without any reason.
11. CD is compulsory for all members for availing benefits of society schemes. In case of non-submission of CD upto 10 months, membership account in society may be freezed/suspended.
12. Annually SMS charge, welfare fund & any other fund (as per society scheme)will be deposited by me.
13. CD - 200/- Rs. per month is compulsory and CRD of Rs.500/- per month is compulsory for a period of 05 years.
14. Annual Welfare and Risk Fund – 150/- Rs. Per year
15. Any other term/condition which will be approved/decided by the society, will be acceptable to me.

Note : In case of resignation from society membership, an application alongwith a welfare fund/cancellation charge of Rs. 500/- (non refundable) will be submitted and after acceptance of registration, Balance amount will be refunded within 90 days.
